(Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information)

INTRODUCTION:

The SEBI has notified the Securities and Exchange Board of India (SEBI)(Prohibition of Insider Trading) Regulations, 2015 (" the Regulations") on 15th January ,2015 effective from 15th May, 2015 which has repealed the SEBI (Prohibition of Insider Trading) Regulations, 1992.

The SEBI Notification No. SEBI/LAD-NRO/GN/2018/59 dated 31.12.2018 has notified Securities and Exchange Board of India (Prohibition of Insider Trading) (Amendment) Regulations, 2018, which shall come into force on 1st April, 2019

The Board of Directors of Every Company, whose securities are listed on a Stock Exchange, shall formulate and Publish on its official website, a Code of Practices and procedures for fair disclosure of unpublished price sensitive information (UPSI) that it would follow order to adhere to each of the principles as stated in Schedule A of the Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015.


This document embodies the Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information to be adopted by the Company and followed by its Directors, Officers, Employees and Connected Persons. The Code seeks to ensure timely, fair and adequate disclosure of price sensitive information to the investor community by the Company to enable them to take informed investment decisions with regard to the Company's Securities.

CODE OF FAIR DISCLOSURES OF THE COMPANY:

- 1. The Company shall promptly make disclosure of unpublished price sensitive information that would impact price discovery no sooner than credible and concrete information comes into being in order to make such information generally available.
- 2. The Company shall follow uniform and universal dissemination of unpublished price sensitive information to avoid selective disclosure.
- 3. The Company Secretary/Compliance Officer of the Company shall act as Chief Investor Relations Officer to deal with dissemination of information and disclosure of Unpublished Price Sensitive Information.



- 5. The Company shall ensure appropriate and fair response to queries on news reports and requested for verification of market rumorers by regulatory authorities.
- 6. The Company shall ensure that information shared with analysts and research personnel is not unpublished price sensitive information.
- 7. The Company shall develop and implement best practices to make transcripts or records of proceedings of meeting with analysis and other investor relations conferences on the official website simultaneously with such meet to ensure official confirmation and documentation of disclosures made.
- 8. The Company shall handle all Unpublished Price Sensitive Information on a need -to- know basis and for legitimate purpose. The legitimate purpose shall include sharing of unpublished price sensitive information in ordinary course of business by an Insider with Partners, Collaborators/ Lenders, Customers, Suppliers, Merchant Banker, Legal Advisors, Auditors, Insolvency Professionals or other advisors or consultants provided that such sharing has not been carried out to evade or circumvent the prohibitions of PIT regulations.
- 9. The Company shall maintain digital database with time stamping and audit trails to ensure non-tampering of the data base containing name and PAN of the person/entity(ies) with whom information is shared pursuant to Legitimate Purposes and name and PAN of Designated Person along-with their immediate relatives.

AMENDMENTS:

- a) The Board may, subject to applicable laws amend any provision(s) or substitute any of the provision(s) with the new provision(s) amend any of the clauses of the above Code in whole or in part or replace the Code entirely with a new Code.
- b) The Board may also establish and stipulate further rules and procedures, from time to time, to give effect to this Code and to ensure fair disclosure of price sensitive information.
- c) This Code and every subsequent modification, alteration or amendment made thereto, shall also be intimated to the Stock Exchange where the securities of the Company are listed.
