## NOMINATION AND REMUNERATION COMMITTEE

### (TERM OF REFERENCE, PROCEDURE AND POLICIES)

#### MEMBERSHIP

The Committee shall consist of a minimum 3 non-executive directors, 2/3 of them being independent. Minimum two members or one third of the members of the Committee whichever is greater, shall constitute a quorum for the Committee meeting. The members of the Committee shall be appointed or removed by the Board of Directors.

#### CHAIRMAN

The Chairman of the Committee shall be an independent director. In the absence of the Chairman, the members of the Committee present at the meeting shall choose one amongst them to act as Chairman. The Chairman of the Committee could be present at the Annual General Meeting of the Company to answer shareholders queries or may nominate some other member to answer the shareholders' queries. However, the Chairman of the Board shall decide who would answer the queries.

#### TERM OF REFERENCE

- To identify persons who are qualified to become directors and who may be appointed in senior management in accordance with the criteria laid down, recommend to the Board their appointment and removal and shall specify the manner for effective evaluation of performance of Board, its committees, Chairperson and individual directors to be carried out by the Board, by the NRC or by an independent external agency and review its implementation and compliance.
- To evaluate the balance of skills, knowledge and experience of Independent Directors and on the basis of such evaluation, prepare a description of the role and capabilities required of an independent director during his/her appointment as an Independent Director
- To formulate criteria for determining qualifications, positive attributes and independence of a director and recommend to the Board a policy, relating to the remuneration of the directors, key managerial personnel and other employees;
- To lay down / formulate criteria for performance evaluation of independent directors & the Board.
- Devising a policy on Board Diversity
- While formulating the remuneration policy, to ensure that –
  - a. the level and composition of remuneration is reasonable and sufficient to attract, retain and motivate directors of the quality required to run the company successfully;
  - b. relationship of remuneration to performance is clear and meets appropriate performance benchmarks; and
  - c. Remuneration to Directors, Key Managerial Personnel and Senior Management involves a balance between fixed and incentive pay reflecting short and long-term performance objectives appropriate to the working of the company and its goals.
- To take into account financial position of the company, trend in the industry, appointee's

- To ensure 'Fit & Proper' status of the proposed/ existing directors.
- To recommend to board, whether to extend or continue the term of appointment of the independent director, on the basis of the report of performance evaluation of independent directors.
- To review and approve the remuneration and change in remuneration payable to the whole-time directors and senior management.
- To recommend to board all remuneration payable to senior management (i.e. members of the core management team, i.e. members one level below the chief executive officer/ whole time director and shall specifically include Company Secretary and Chief Financial Officer)
- To have relevant experience of contributions to the deliberations of the Board and Corporate Governance.

## SELECTION OF NEW DIRECTORS

Factors to be considered when reviewing a potential candidate for Board appointment include without limitation:

- To have relevant experience in Finance/ Law/ Management/ Sales/Marketing/ Administration/ deliberations of Board/ Corporate Governance or the other disciplines related to company's business.
- The capability of the candidate to devote the necessary time and commitment to the role.
- This involves a consideration of matters such as other Board or executive appointments; and Potential conflicts of interest, and independence.

## CRITERIA FOR DETERMINING QUALIFICATIONS, POSITIVE ATTRIBUTES & INDEPENDENCE OF DIRECTOR

- Qualifications of Independent Director:-

An Independent director shall possess appropriate skills, experience and knowledge in one or more fields of finance, law, management, sales, marketing, administration, research, corporate governance, operations or other disciplines related and beneficial to the company's business.

- Positive attributes of Independent Directors:-

An independent director shall be a person of integrity, who possesses relevant expertise & experience and who shall uphold ethical standards of integrity and probity; act objectively and constructively; exercise his responsibilities in a bona-fide manner in the interest of the company; devote sufficient time and attention to his professional obligations for informed and balanced decision making; and assist the company in implementing the best corporate governance practices.

An Independent director should meet the requirements of the Companies Act, 2013 and SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, concerning independence of directors.

## POLICY ON BOARD DIVERSITY

The Company should endeavour to have mix of Directors with experience in diverse field's viz. Finance, Law, Management, Sales and Marketing, Technical, Administration, Corporate Governance, factory operations and other discipline related and beneficial to the Company's operations.

The Board should have an optimum number of executive and non- executive directors and not less than 50% of the Board should consists of the non- executive directors and shall have at least one (1) woman director on the Board subject to the applicable laws. While appointing the independent directors, care should be taken as to independence of the proposed appointee. Directorships in other Companies may also be taken in account while determining the candidature of a person.

## REMUNERATION POLICY

- In discharging its responsibilities, the Committee must have regard to the following policy objectives:
  1. to ensure that the Company's remuneration structures are equitable and aligned with the long-term interests of the Company and its shareholders;
  2. to attract and retain skilled executives;
  3. to structure short and long-term incentives that are challenging and linked to the creation of sustainable shareholder returns; and
  4. To ensure any termination benefits are justified and appropriate.
  5. To consider professional indemnity and liability insurance for Directors and senior management.
- The Committee must at all times have regard to, and notify the Board as appropriate of, all legal and regulatory requirements, including any shareholder approvals which are necessary to obtain.

### Remuneration to Non-Executive Directors (NED's):

- NED's shall be paid a sitting fee for every meeting of the board and committee thereof attended by them as member. The present sitting fees is Rs.10000/- for Board , Rs 10,000 for Audit Committee meeting and Rs. 5000/- for other Committees .
- The present sitting fee is Rs 5000 for Attending Annual General Meeting and Rs 5000 for Separate Meeting of Independent Director.
- NED's shall not be entitled to any commission on net profit of the Company.

### Remuneration to Key Managerial Personnel & other employees:

In the event of any conflict between the provisions of this Policy and any statutory enactments/rules, the provisions of such statutory enactments/rules shall prevail over this policy and automatically be applicable and the relevant provisions of the Policy would be amended/modified in due course to make it consistent with the statutory requirements.

## EFFECTIVE DATE

This revised policy shall be effective w.e.f. 1<sup>st</sup> September , 2024.
